## **EMPLOYEE ACCIDENT/INJURY OR ILLNESS PROCEDURES**

The following procedures are to be followed in case of an accident, injury or illness to any employee that occurs while in the performance of duties for Grand Rapids Community College. **NOTE**: To be considered an employee you must be on Grand Rapids Community College payroll at the time of injury. If you are not working at the College but are contracted through a temporary service, we are not responsible for your treatment. Please contact the HR Benefits Office (Ext. 4052) if this situation occurs.

**If you are injured on-the-job:** You must report your injury promptly to Campus Police (X-4010) and your supervisor or Department Head. Injured employee must complete an "EMPLOYEE INJURY REPORT FORM", have your supervisor sign the form and send a copy to the Human Resources/Benefits Office. It is imperative that you <u>report all injuries</u>, regardless of severity, even if medical treatment is not necessary. Employees should promptly report all work-related injuries, even if the injury is discovered later or the work-related injury is not rapidly apparent.

If the injury is life threatening: Please go the nearest emergency room or call 911. Campus Police or Human Resources/ Benefits Office (Ext. 4052) should be contacted as soon as possible.

If injury occurs after regularly scheduled GRCC hours when Campus Police are not on campus, and immediate medical attention is needed, employee should seek treatment at the After-hours Emergent Injury Care: Blodgett Hospital. If the injury is life threatening, please go the nearest emergency room or call 911. Human Resources/ Benefits Office (Ext. 4052) should be contacted during the next business day.

Seeking treatment for non-life threating injury: An "Occupational Services Authorization to Treat" form must be obtained prior to seeking medical treatment at Spectrum Health Occupational Clinics for any on-the-job injury. Individuals listed on the bottom of this page have been approved to authorize treatment and can provide you with Authorization to Treat Form. Note: Medical services received from an employee's personal physician will not be paid by Grand Rapids Community College.

**After treatment:** Return any after care instructions to Supervisor or Department Head for review of restrictions, if any. After reviewing, supervisors are required to send all paperwork to the Human Resources/Benefits Office, Administration Building-2nd Floor at the DeVos Campus – Attn: Maria Belmares Herrera.

Physician referrals: If treatment by a Specialist is necessary, the workers compensation carrier will review referral request and contact Spectrum Health before scheduling you with the proper physician or specialist. Spectrum Health Occupational clinic should not contact you for anything else at this point. If they do, please refer them to the Human Resources/ Benefits Office (Ext. 4052).
