Introduction to Distance Learning: Policy 8.32

Name Change: Distance Learning Training Materials for Students: Policy 8.32

February 11, 2025

Purpose

Policy 8.32 is designed to ensure that all GRCC students have access to training and materials to support their success in distance learning and in the use of the Learning Management System (LMS). In addition, this policy is written to promote equitable and inclusive access to distance learning.

Decision

On February 11, 2025, the AGC membership voted to approve the revised Policy 8.32 Distance Learning Training Materials for Students (previously called Introduction to Distance Learning) as part of a regularly scheduled review. The revised policy statement follows:

GRCC will provide training and support to students on distance learning and use of the Learning Management System (LMS).

Rationale/ Supporting Data

The committee updated the policy as follows:

- Students are no longer required to complete the Introduction to Learning Course prior to enrolling in an online or hybrid course. The language to this effect was removed from the Policy.

The committee reviewing this policy:

- Sought and included input from AGC members at three meetings.
- Responded to any input from departments, programs, and individual faculty members.
- The committee benchmarked 19 Michigan Community Colleges.

Implications for Action

The Policy 8.32 team recommends that the following language be added to the Procedures section of the policy document:

In collaboration with faculty and students, TLDE will develop and maintain Navigating Canvas, an asynchronous unfacilitated training to help students utilize GRCC's Learning Management System (LMS). Navigating Canvas will be available to all students from GRCC's website and Canvas resources provided to faculty will include a link to Navigating Canvas from within their courses.

In collaboration with faculty and students, TLDE and Media Technologies will develop and maintain a video describing GRCC's distance learning modalities. The video will be available on the TLC web page.

"TLC" was unclear to members of the AGC body.

I am charging the Teaching, Learning, and Distance Education (TLDE) department, led by the department's Executive Director, to coordinate implementation of this policy revision. This will include updating the policy document, reviewing the procedures, and making updates to the procedures according to the recommendations outlined in the implications for action section above (developing and implementing the Navigating Canvas training, creating a video to support understanding of GRCC's learning modalities, and promoting awareness of the [Technology Learning Center \(TLC\)](#)). This will be followed by an update to the Academic and Student Affairs Council once the policy document has been reviewed and updated. Additional steps of implementation will include working with the Provost's Office to update the policy document on the appropriate GRCC webpage and a communication plan about the updated policy document. Full implementation of this revised policy statement should be accomplished no later than the start of the next Academic Year in August 2025.
