- Continue the registration process by clicking where prompted and verifying your account information
- Create a username and password
- You will need to establish three security questions that will be used to verify your identity in the future

To complete the registration, select a personal image and phrase that will be displayed on the LMCU online banking login page.

Attached you will find an HSA beneficiary designation form, as well as an HSA power of attorney form.

The HSA beneficiary designation form has been provided to you, so that you may leave the account to someone in the event of your death. The individual listed as beneficiary would inherit those HSA funds.

The HSA power of attorney form is available to you if you would like to add someone to your HSA that would need full access to the account. The power of attorney would have full access to the HSA, and could receive a debit card in their own name.
