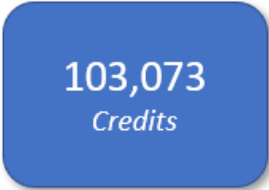
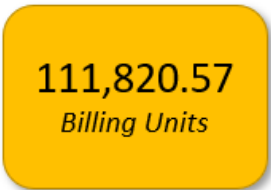
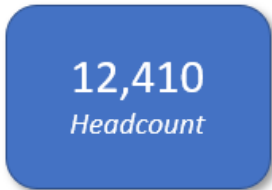
## Fall 2024 Executive Summary

- Based on demographics, our average student continues to be a part-time enrolled white female between the ages of 18-24.
- We achieved 95.46% of our Fall 2024 enrollment stretch goal and exceeded the Fall 2023 enrollment figures by 2.08% for headcount, 1.64% for billing units, and 1.45% for credits attempted which has been acknowledged and celebrated. The enrollment growth since Fall 2022 continues and has been observed nationally for community colleges according to several higher education publications. This growth is not as drastic as the previous year, but we continue to study this unexpected trend to ensure we support initiatives that may be a contributing factor. Some notable observations are:
  - We achieved a 16.33% increase in international students compared to Fall 2023;
  - Our dual enrollment student population and students under the age of 18 experienced significant growth of 18.69% and 9.97% respectively in Fall 2024 compared to Fall 2023;
  - Enrollment for students self-identifying as Hispanic/Latino/Latina grew 10.79% from last fall, continuing their upward trend since Fall 2020;
  - Enrollment for students self-identifying as multiple races (2+) grew 19.42% from Fall 2023
  - We saw growth in new students of 4.14% from Fall 2023;
  - We saw growth in students age 21-24 which is most likely related to the expansion of the Reconnect Grant set to expire on December 31, 2024;
  - We saw a significant growth in Lakeshore Campus enrollment of 23.55% from Fall 2023, which could correlate with the increases previously mentioned as well as the increase in out of district billing units of 4.41%;
  - We saw significant growth in customized training enrollment, thanks in large part to an increase in Michigan New Jobs programming.
- For as much growth as we've seen, there are some areas of opportunity that could be of focus for future enrollment planning.
  - There was a decrease of 9.94% in guest students from Fall 2023;
  - There were decreases in students aged 18-20 and 30 or older (1.17% and 4.99% respectively) since Fall 2023;
  - Our occasional student enrollment (defined as students who experienced an enrollment gap at GRCC between major semesters) was also down 4.83%; however, we are still unsure of whether this is related to observed increases in our returning students or other related efforts;
  - We did not observe as strong of fall-to-fall retention as previous years which suggests that a review of our outreach efforts to students to encourage re-enrollment may be wise. Groups that would benefit from this review could be Black/African American students, Hispanic/Latino/Latina students, Native American/Alaska Native students, students aged 21 and older, part-time enrolled students, and Pell recipients;

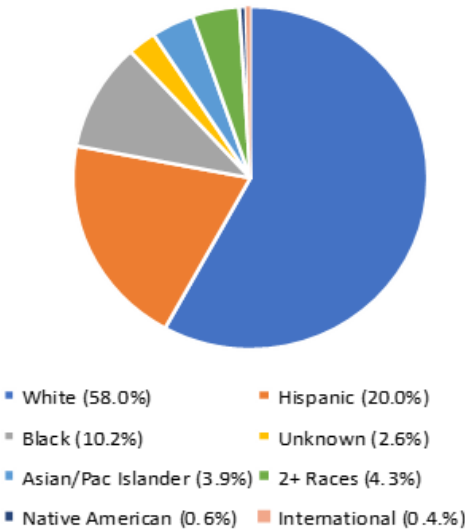
# GRCC | Institutional Research

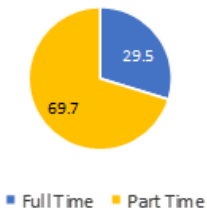

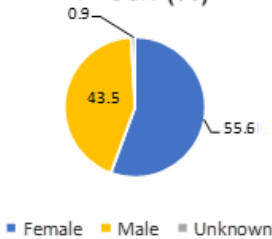
Race/Ethnicity



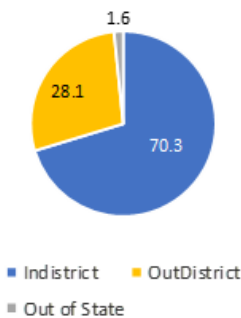
Enrollment Status (%)



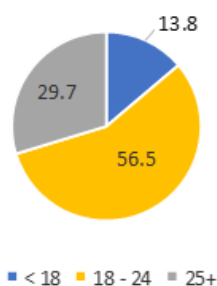
Sex (%)



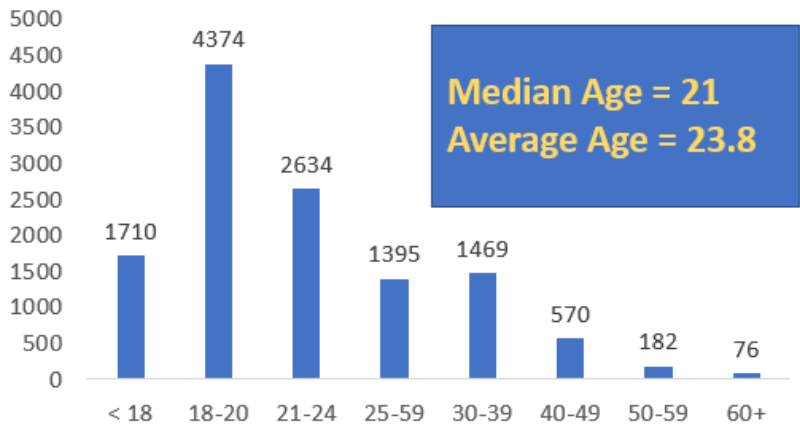
Residency (%)

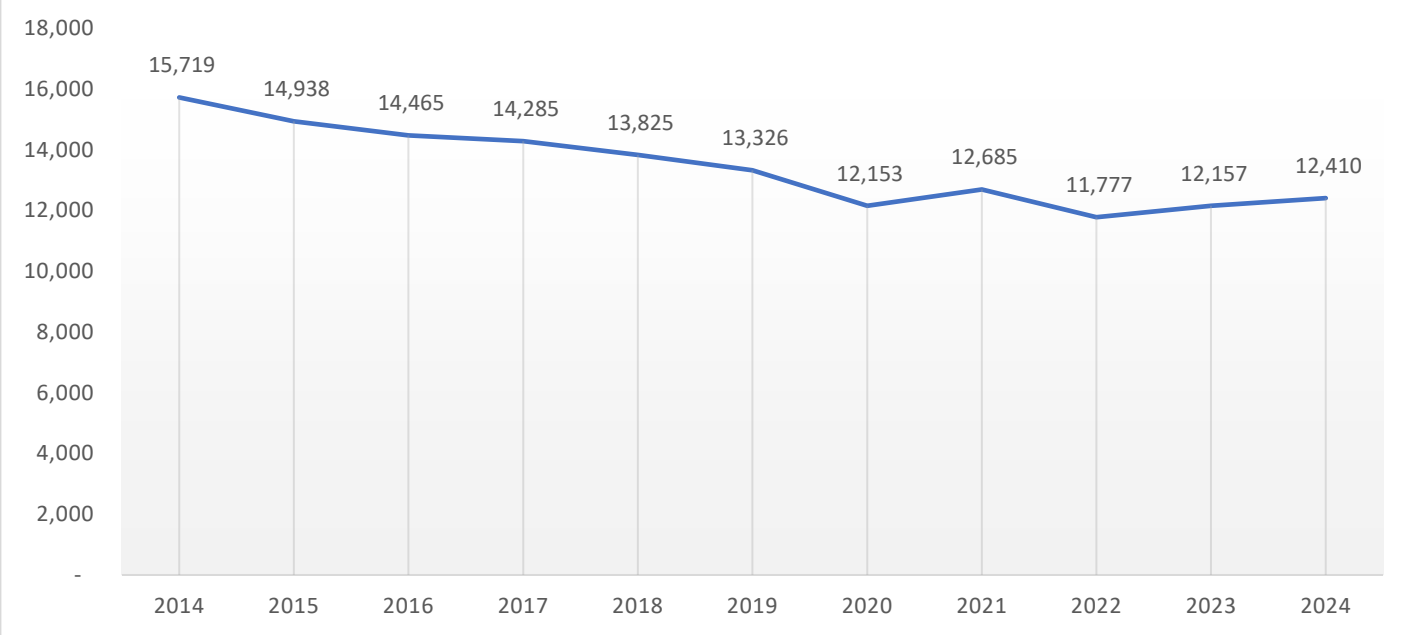


Fall 2024 Age Distribution

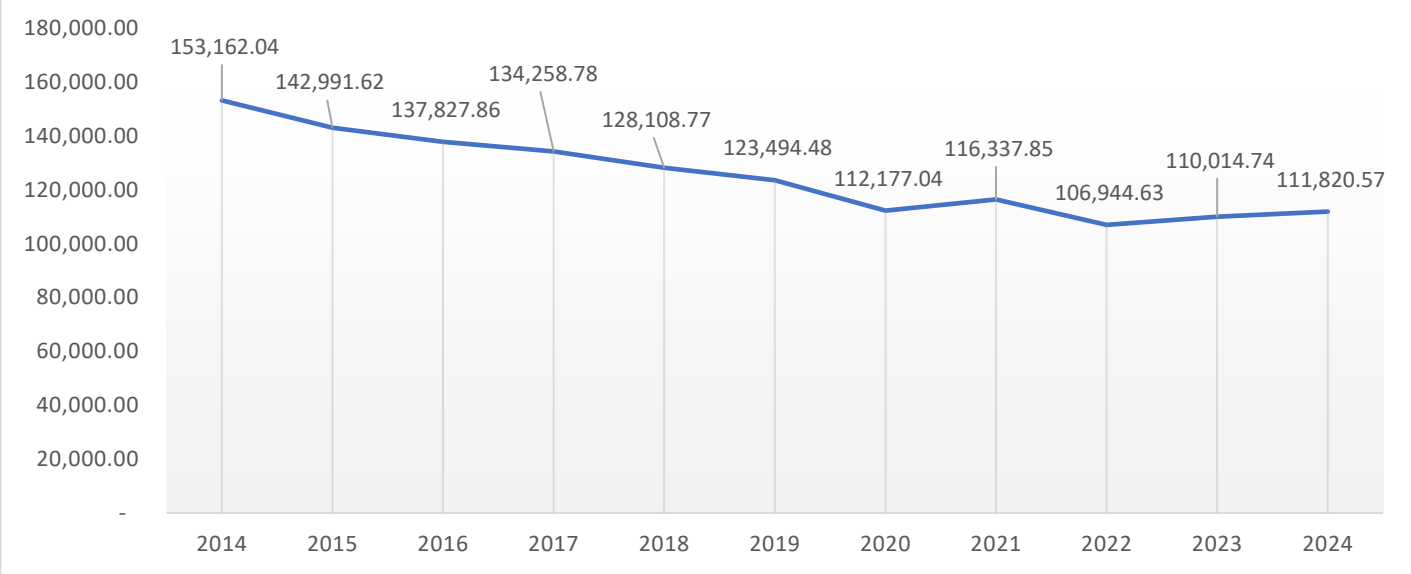

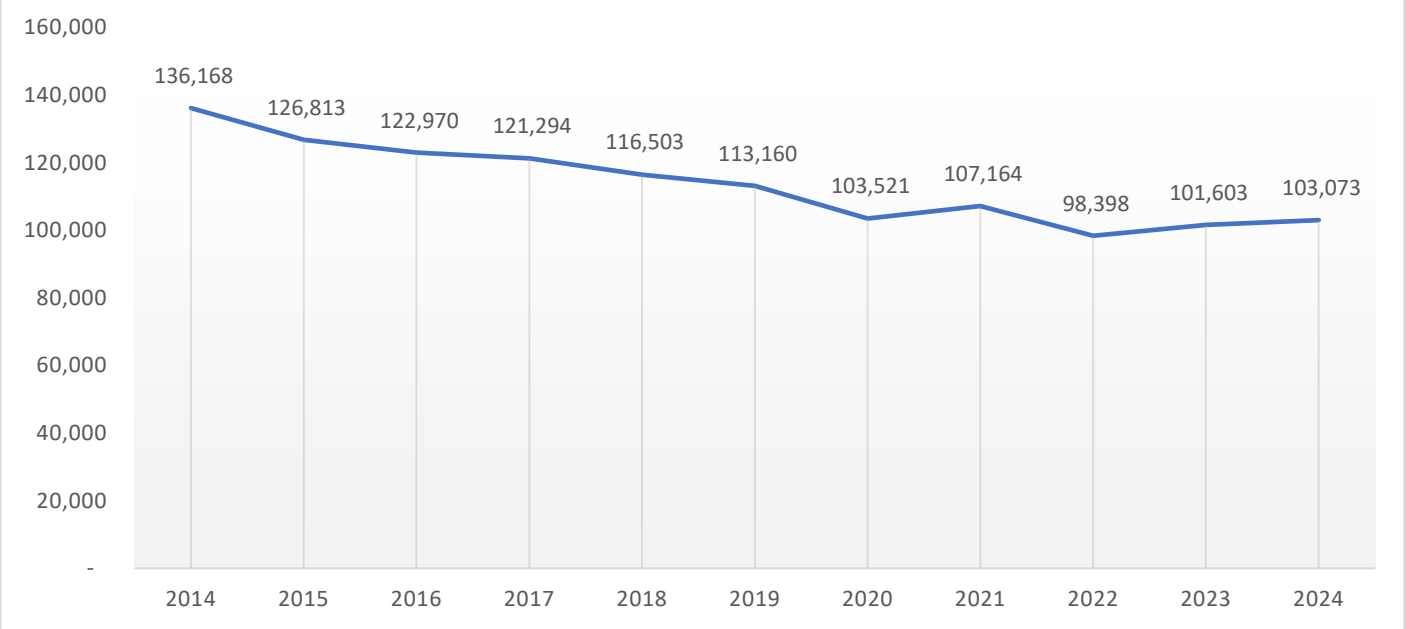
Graph 1: Credit Unduplicated Headcount



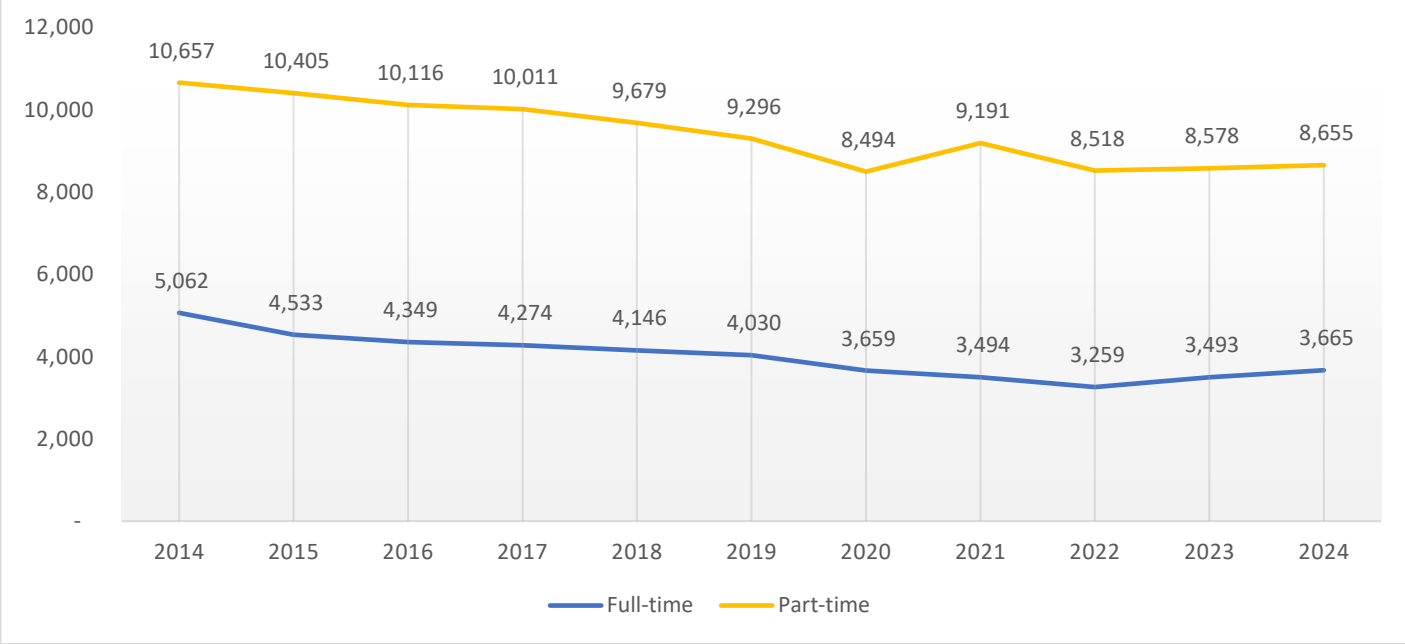
Graph 2: Credit Billing Units



Graph 3: Attempted Credits



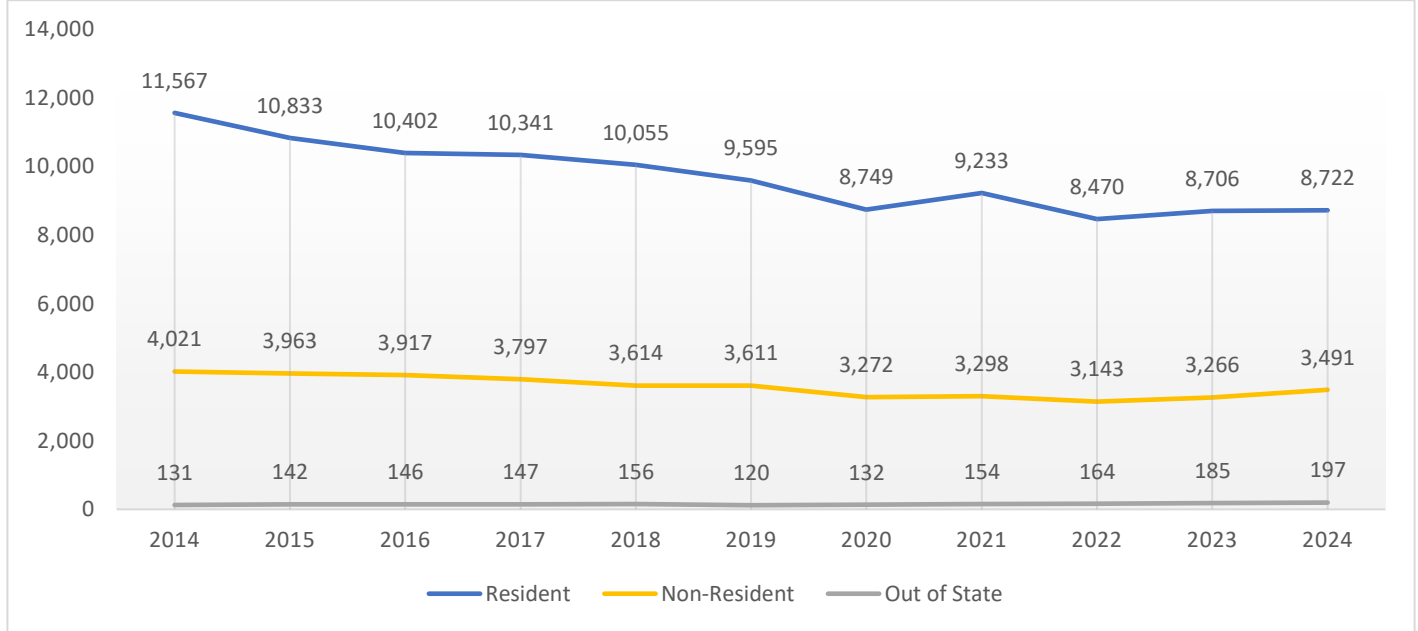
Graph 4: Credit Enrollment Status



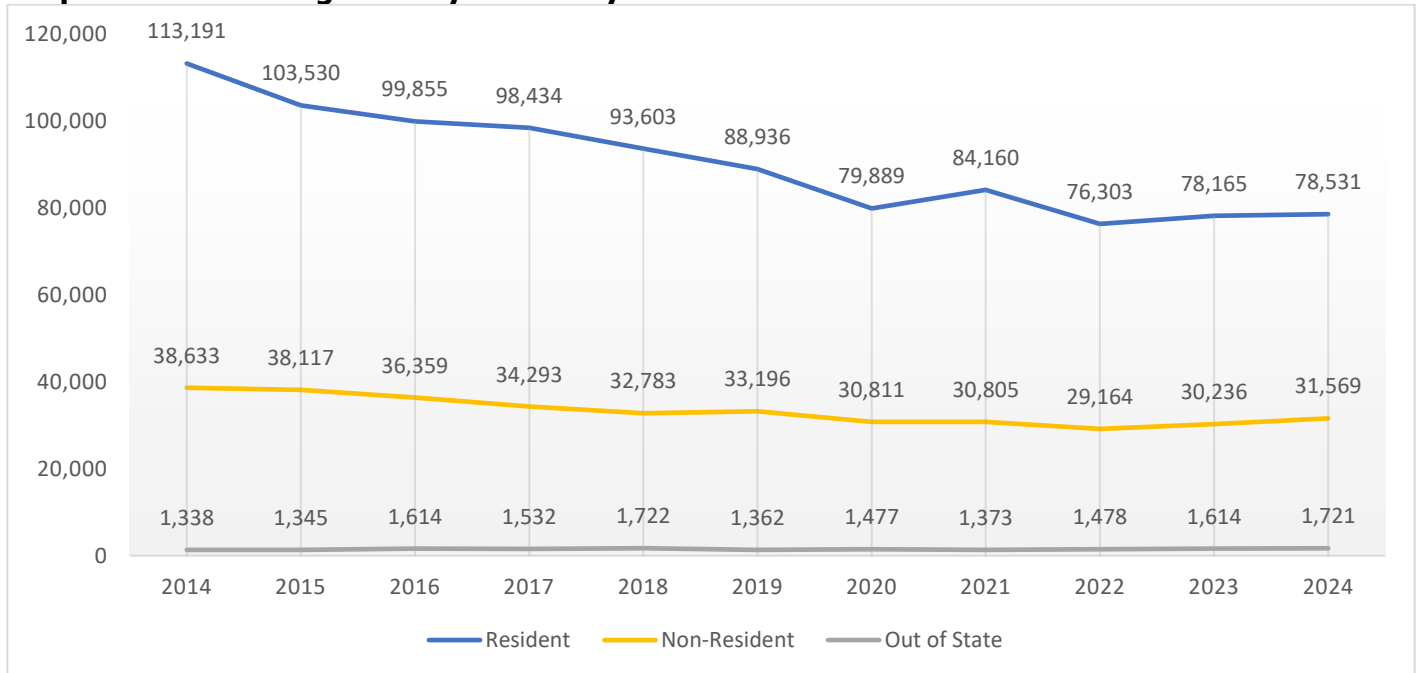

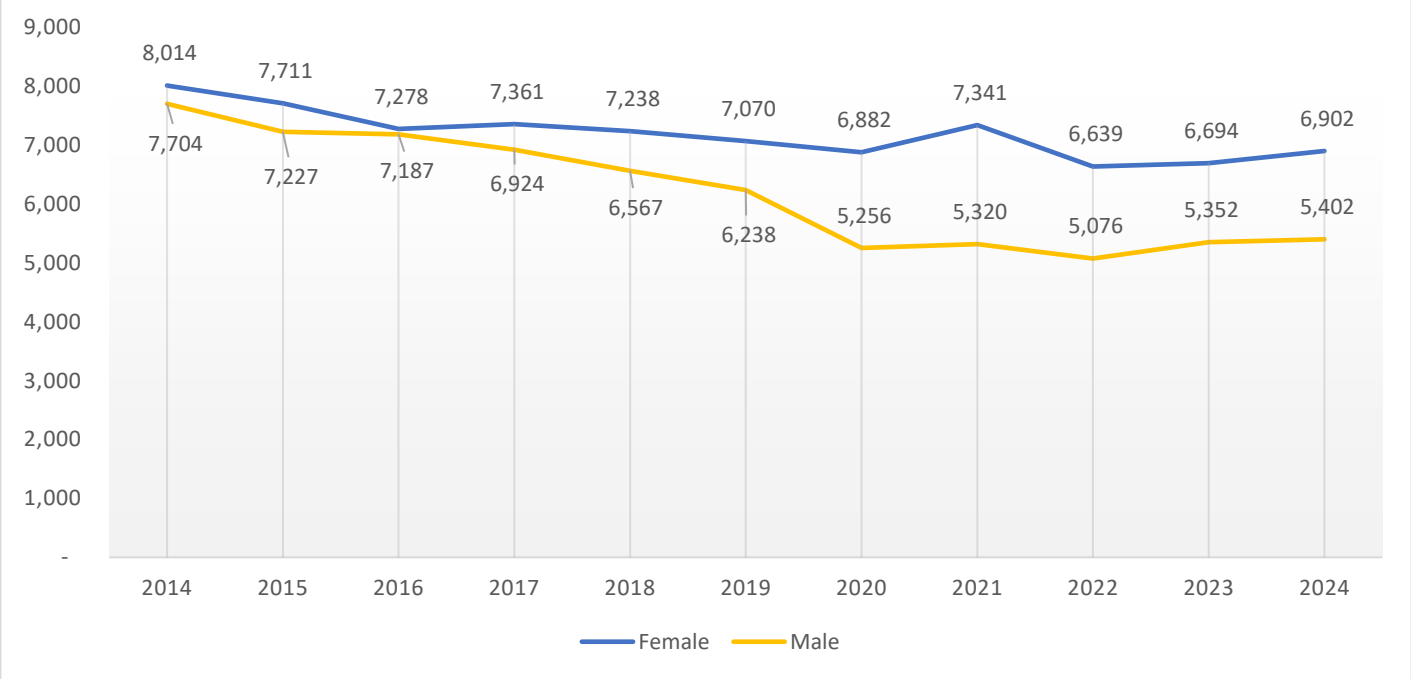
**Graph 5: Credit Unduplicated Headcount by Residency**



**Graph 6: Credit Billing Units by Residency**

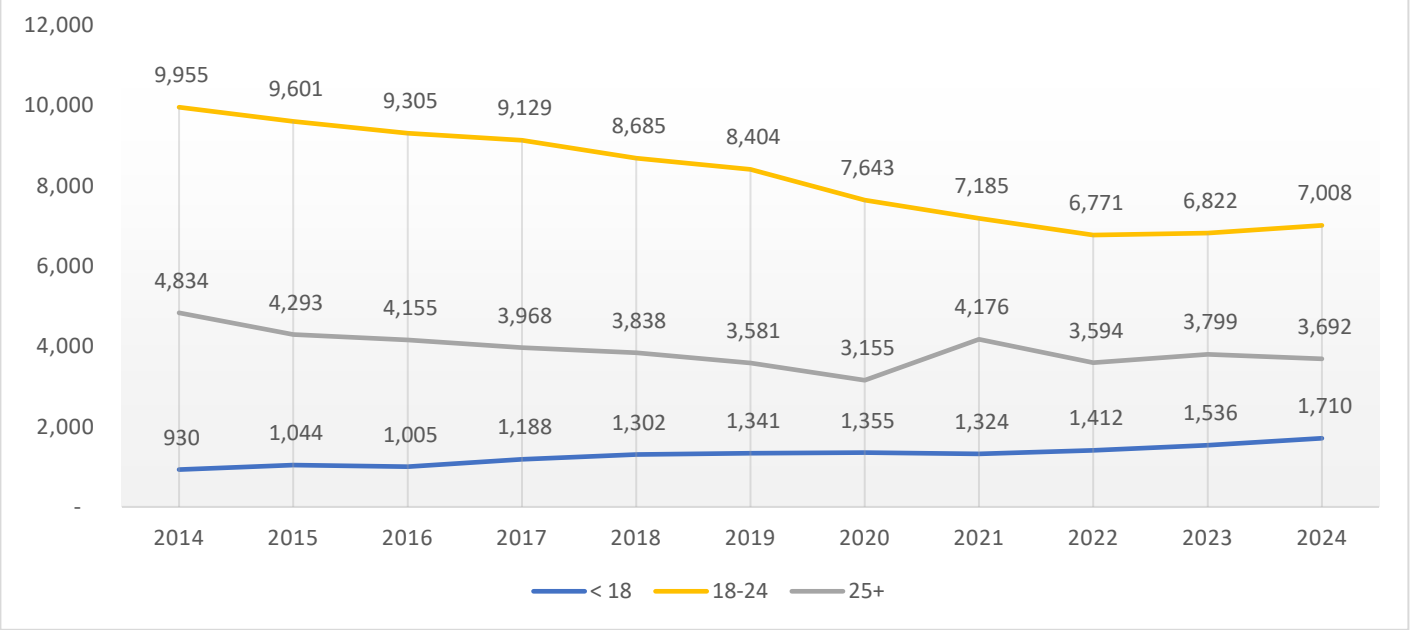


Graph 7: Credit Unduplicated Headcount per Gender

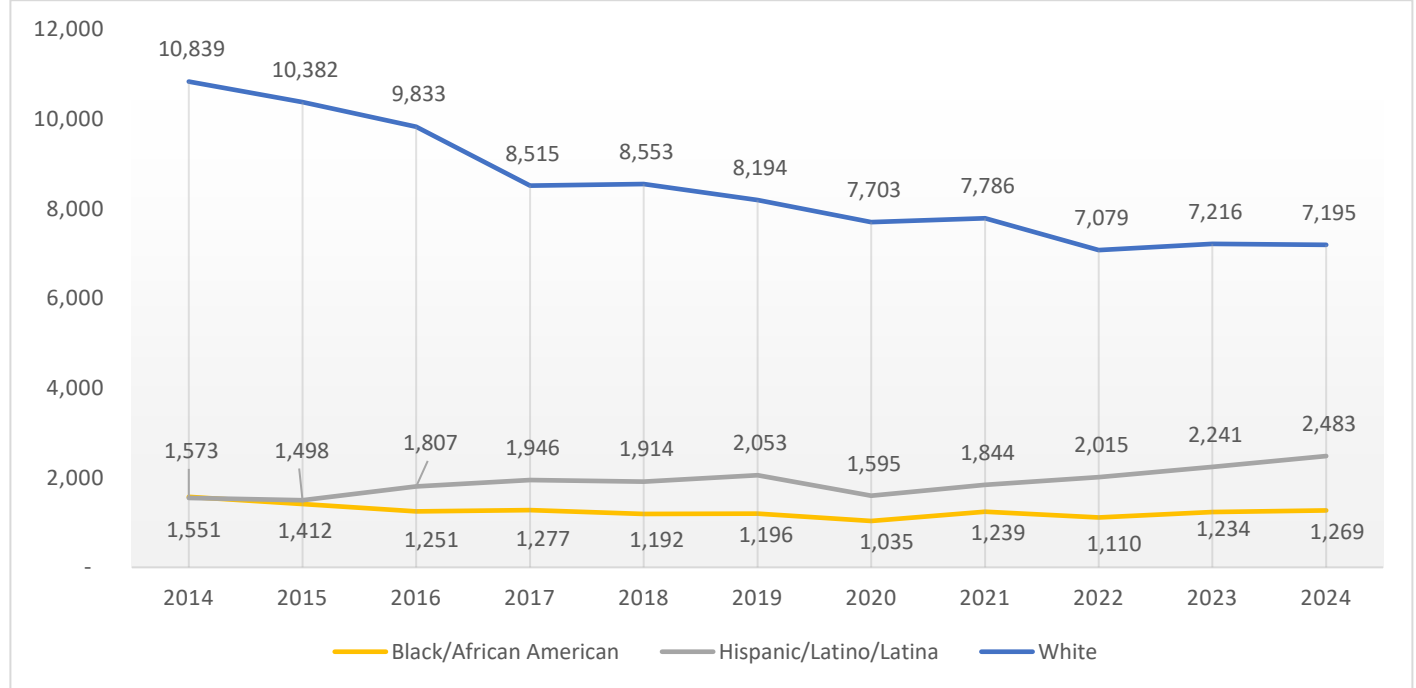

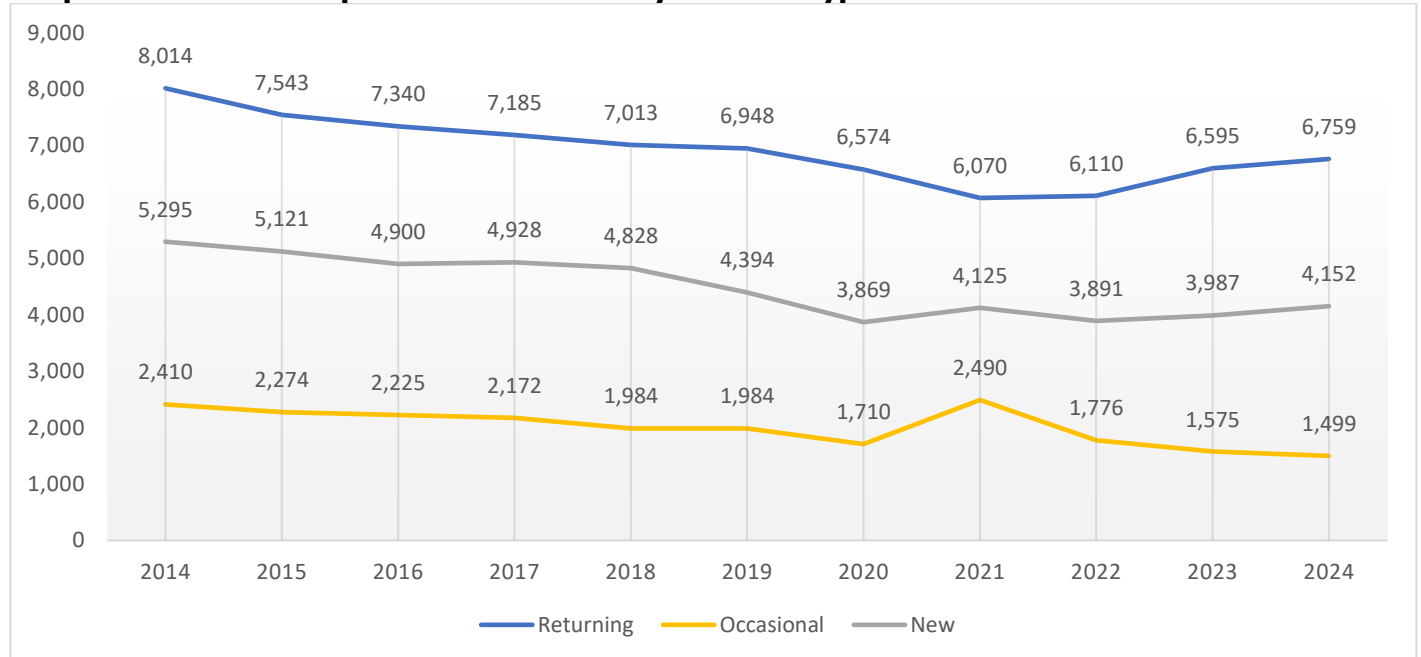
Graph 8: Credit Unduplicated Headcount by Age



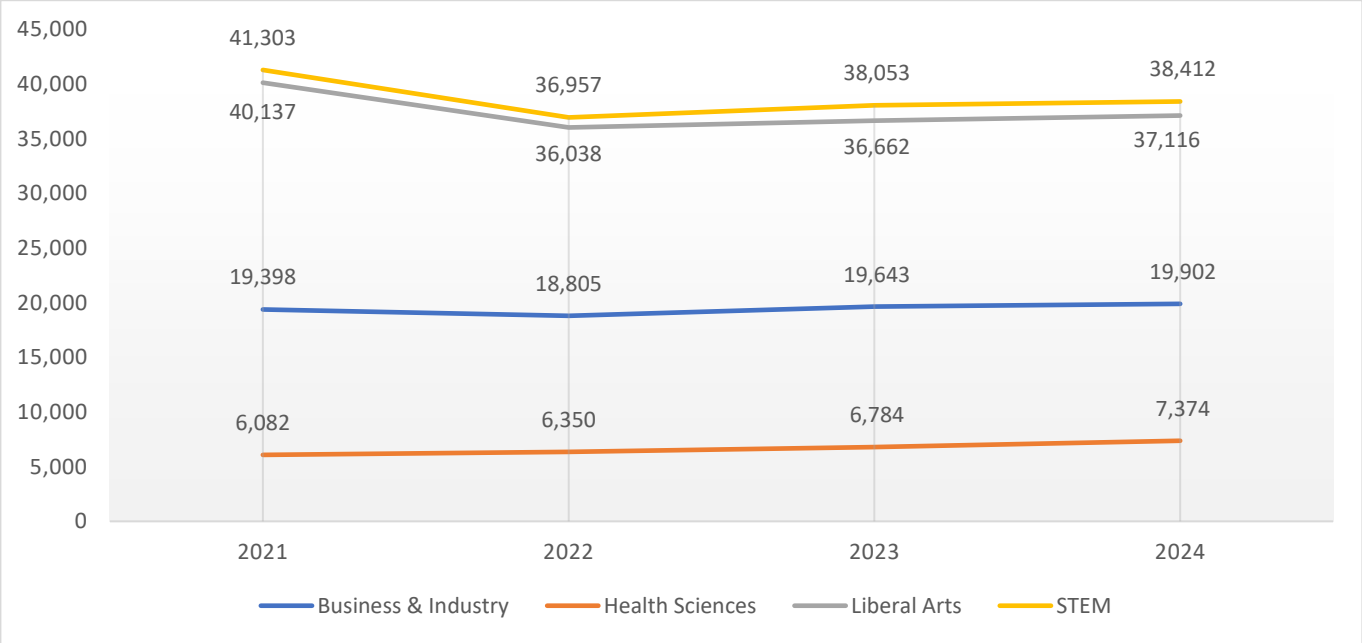
**Graph 9: Credit Unduplicated Headcount by Race/Ethnicity**



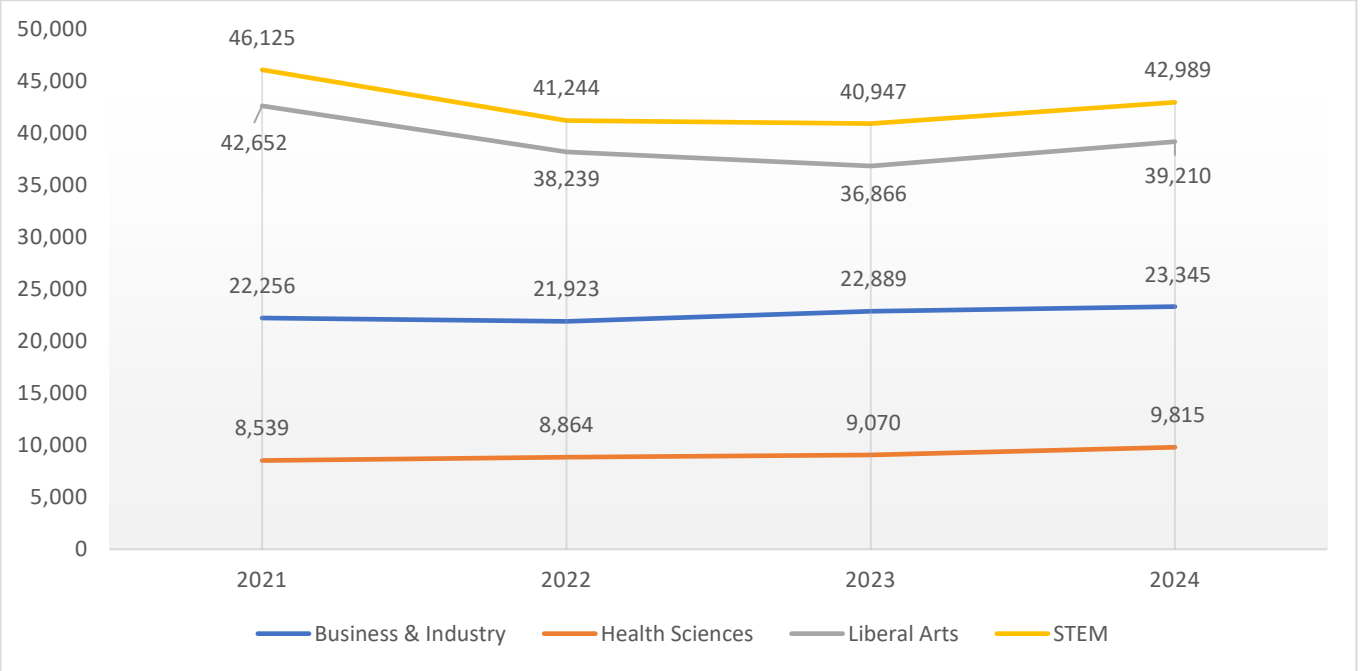
**Graph 10: Credit Unduplicated Headcount by Student Type**
