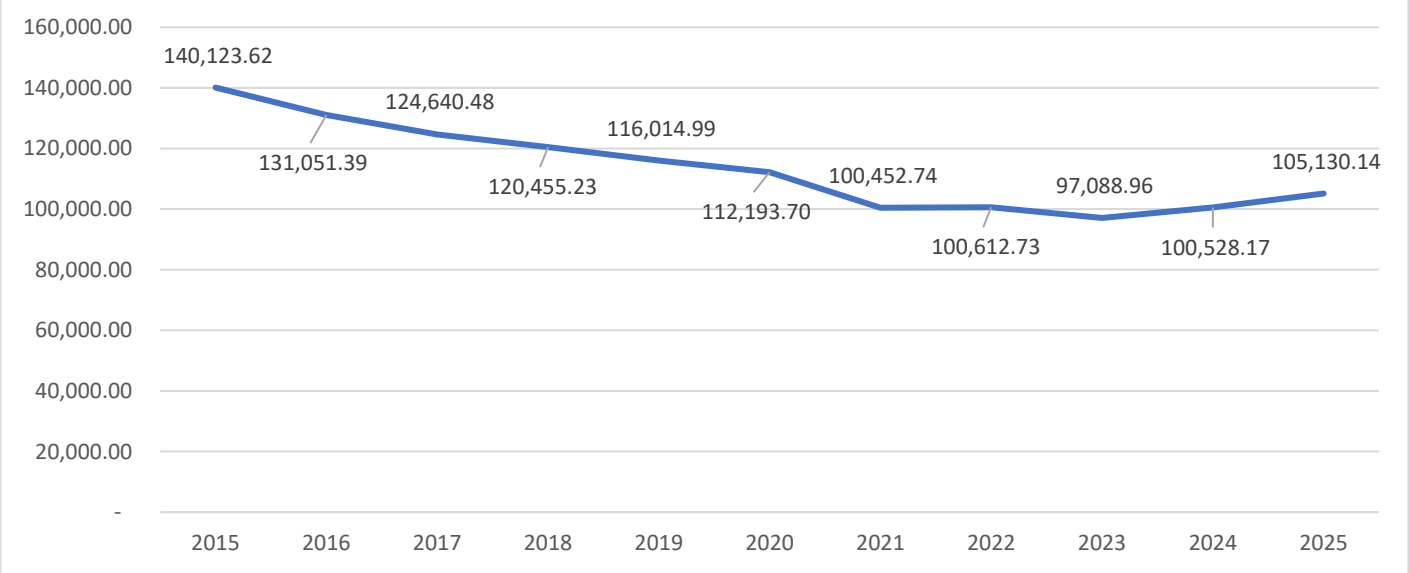

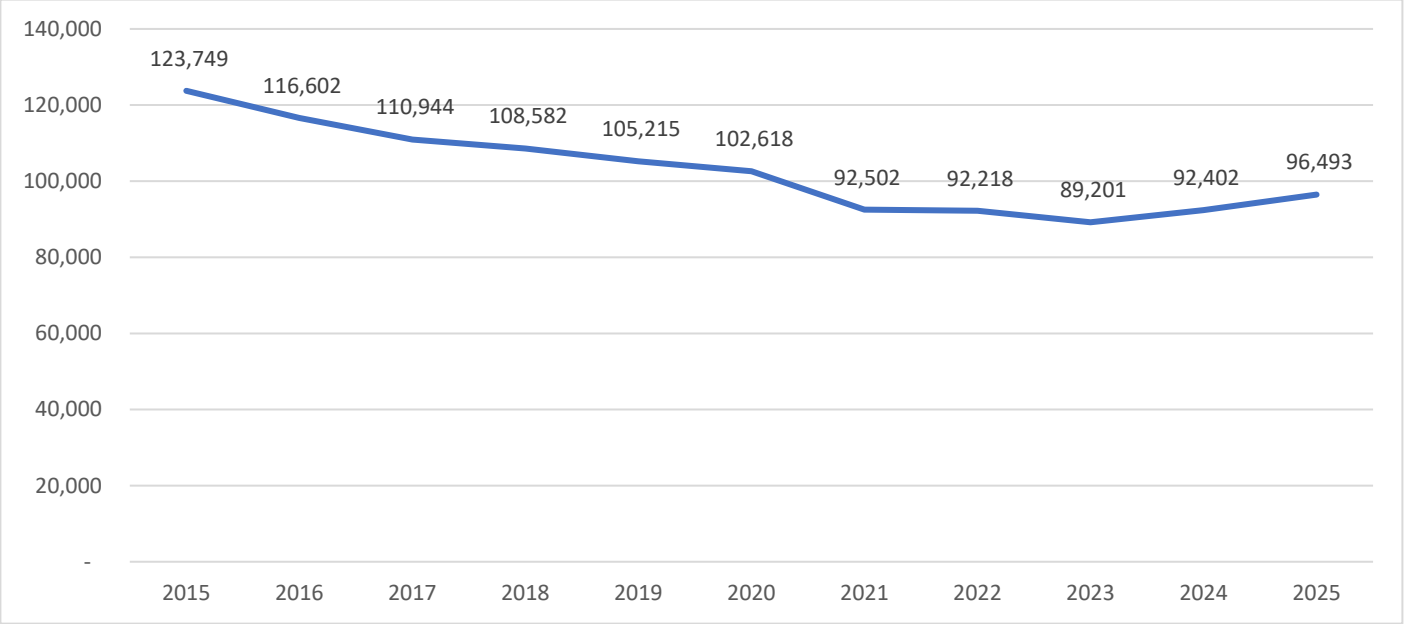
Graph 1: Credit Unduplicated Headcount



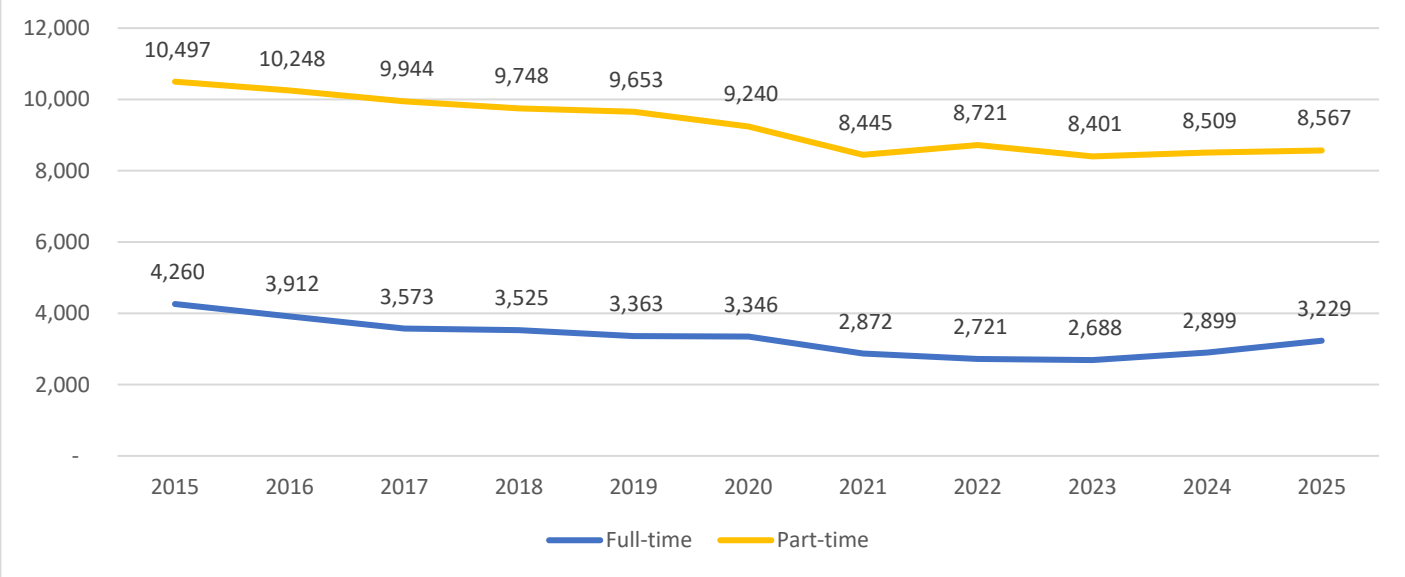
Graph 2: Credit Billing Units



Graph 3: Attempted Credits

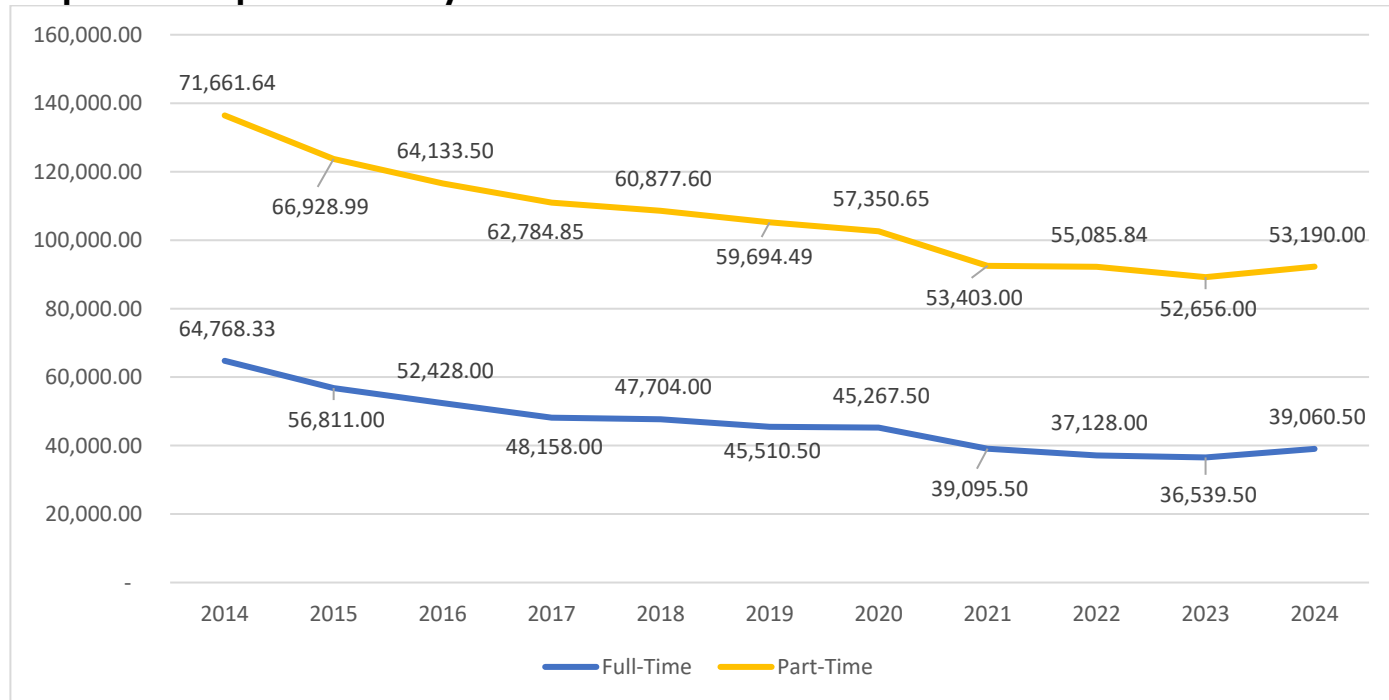


Graph 4: Credit Unduplicated Headcount by Enrollment Status



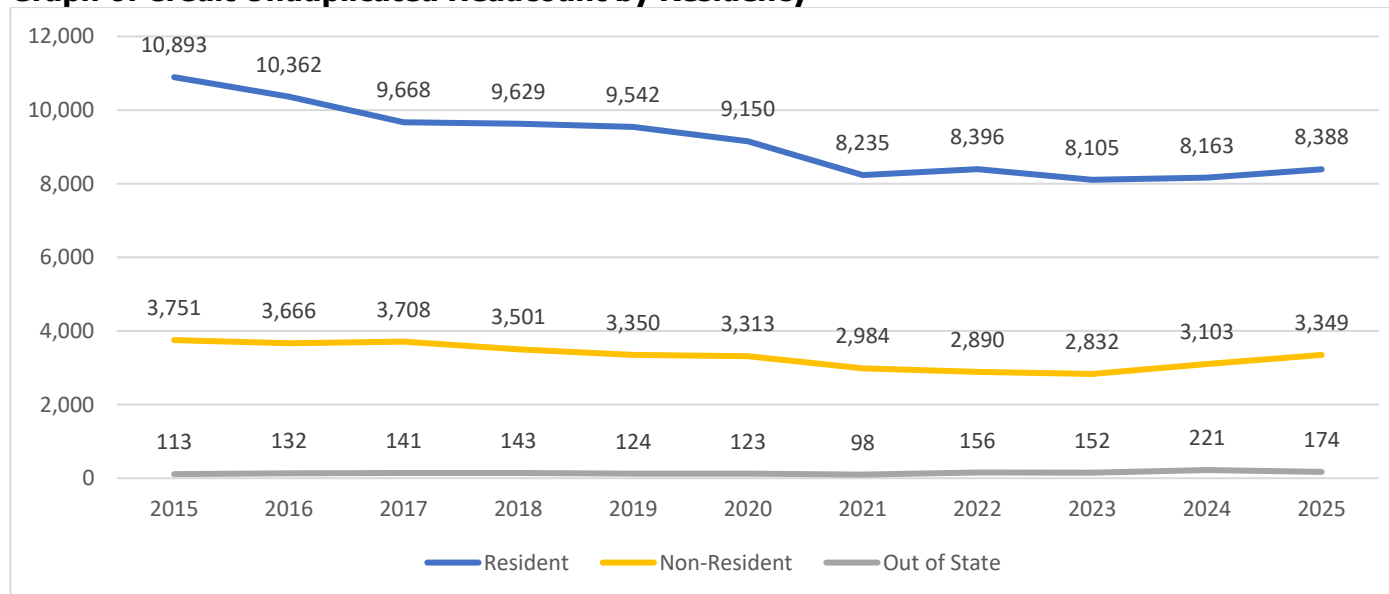

Graph 5: Attempted Credits by Enrollment Status

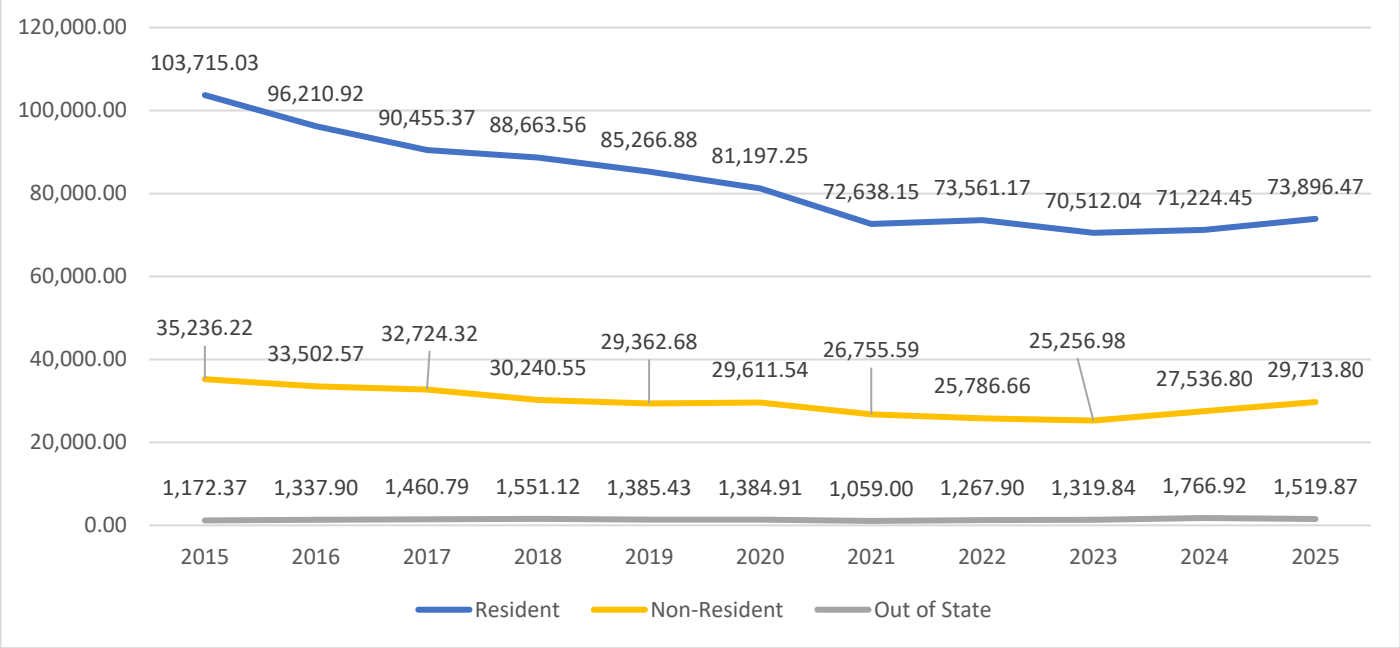

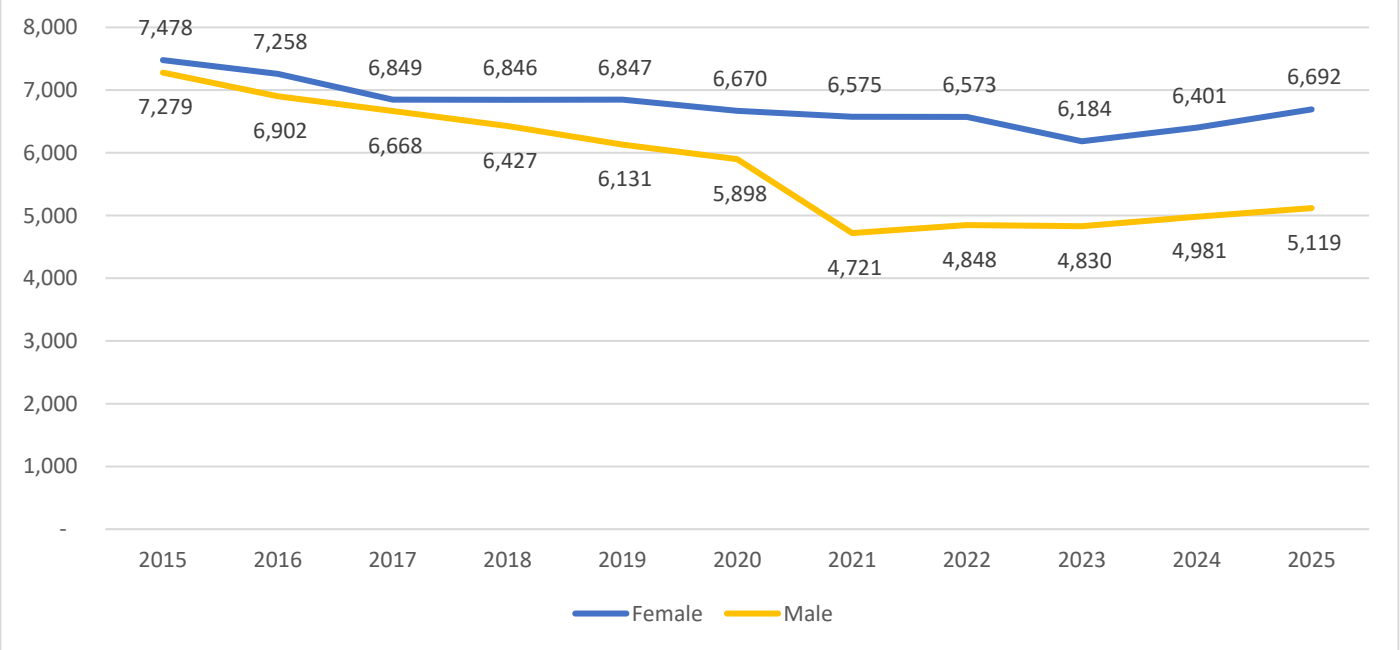
Graph 6: Credit Unduplicated Headcount by Residency



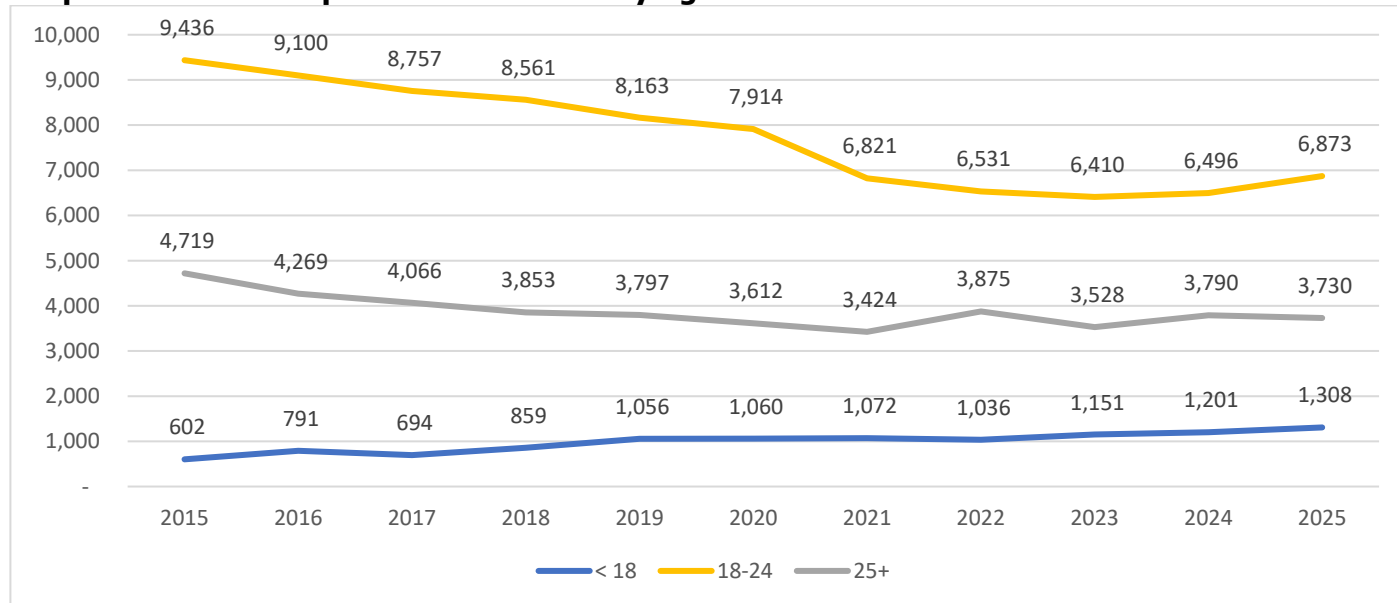
Graph 7: Credit Billing Units by Residency



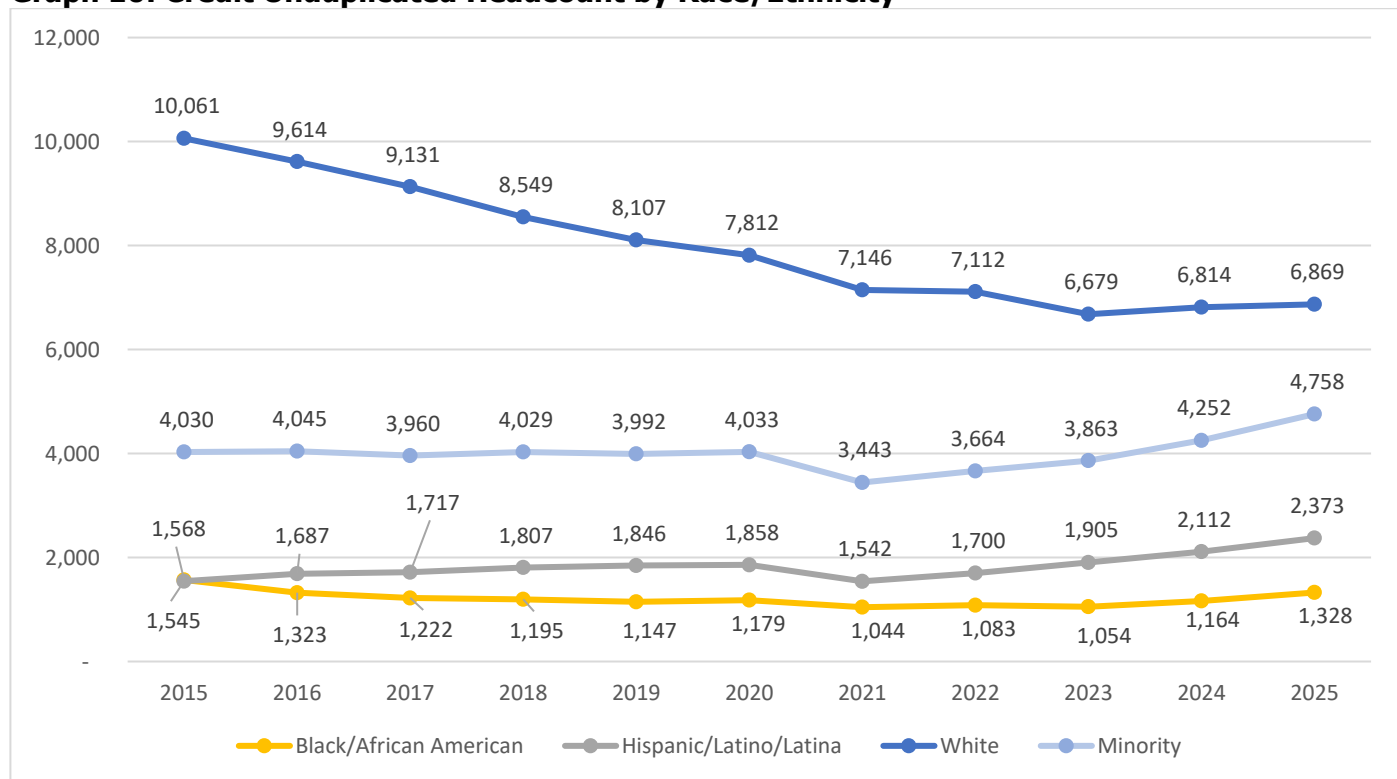
Graph 8: Credit Unduplicated Headcount by Gender



Graph 9: Credit Unduplicated Headcount by Age



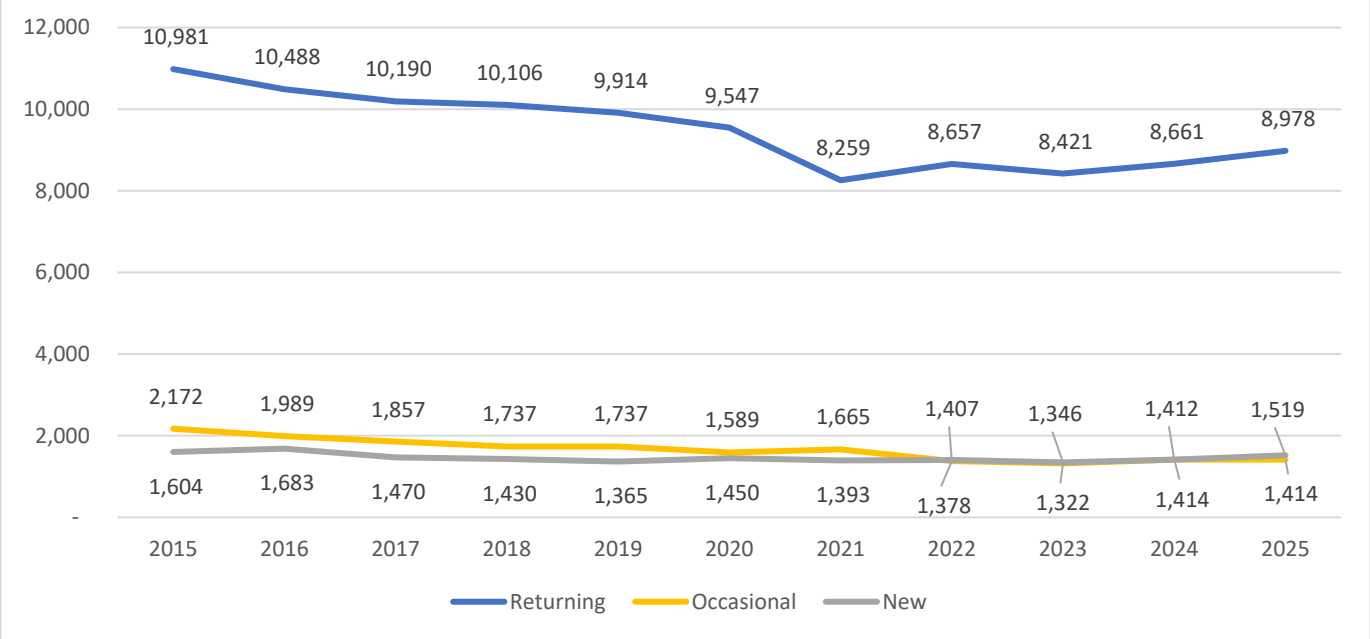
Graph 10: Credit Unduplicated Headcount by Race/Ethnicity



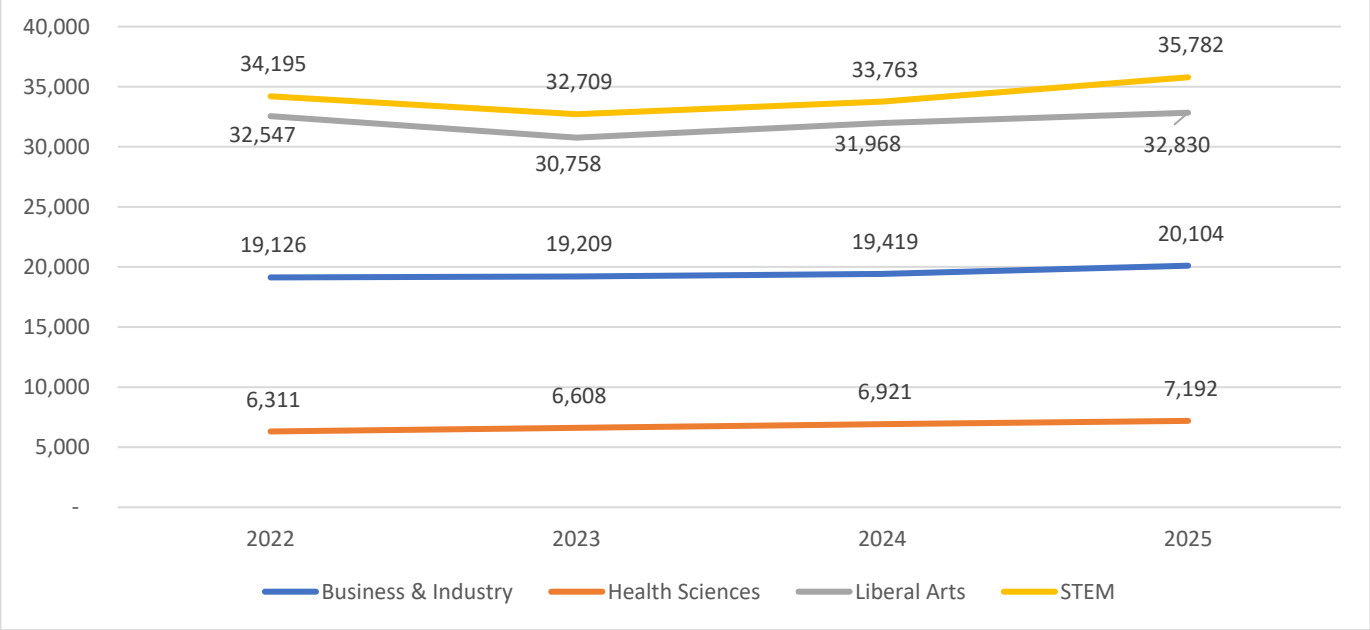

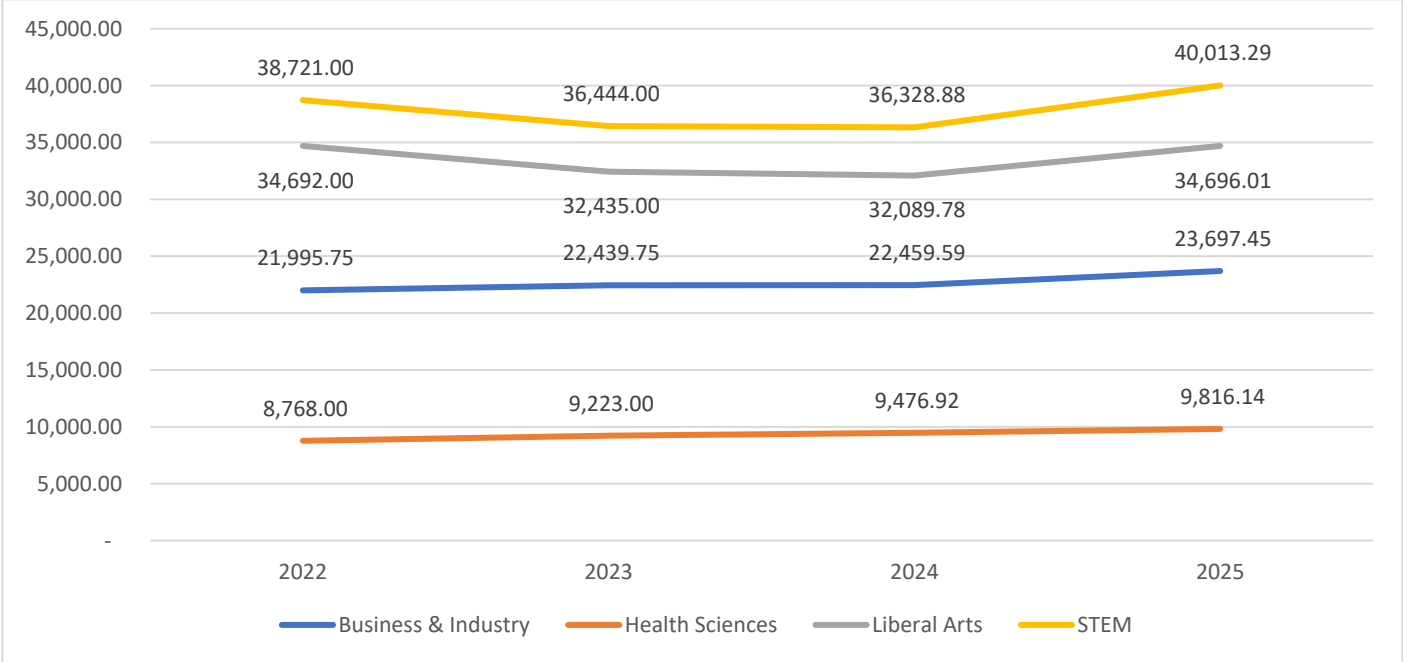
Graph 11: Credit Unduplicated Headcount by Student Type
